## Ugovor o najmu vozila

1. I&J World Wide Investments d.o.o., u daljem tekstu Rent a car 999, daje na korišćenje vozila navedeno na prednjoj strani Ugovora, na vrijeme i po uslovima utvrđenim ovim Ugovorom o najmu.
2. Potpisivanjem ovog Ugovora o najmu korisnik potvrđuje da je preuzeo vozilo o ispravnom stanju i punog rezervoara goriva ukoliko drugačije nije navedeno u Ugovoru.
3. Korisnik se sam platiti gorivo u utoršeno tokom najma.
4. Korisnik se obavezuje da će vozilo vratiti sa svim gumama, alatom, ispravama, standardno i dodatnom opremom kako ga je i preuzeo.
5. Korisnik će vozilo vratiti ugovorenog datuma ili ranije na zahtjev Rent a car-a 999. Ako želi produžiti najam, korisnik će obavijestiti Rent a car 999 i zatražiti saglanost barem 24 sata ranije i tada uplatiti potreban iznos.
6. Vozilom može upravljati samo korisnik ili osoba koja je navedena u Ugovoru kao drugi vozač, ako ima sve potrebne kvalifikacije dokumenata.
7. Vozilo se ne smije koristiti za:
  - Ako je korisnik pod uticajem alkohola ili narkotika
  - Za vuču drugih vozila
  - Ako je pretovareno bilo kojom robom ili putnicima
  - Materijala jako neugodnog mirisa te ikakvog materijala koji može oštetiti vozilo
8. Korisnik ne može prenijeti svoje pravo po ovome Ugovoru niti smije otuditi vozilo ili djelove vozila
9. Ukoliko korisnik prekorači ugovoreni rok vraćanja vozila bez saglasnosti Rent a cara -a 999, vozilo će smatrati ukradenim, a Rent a car 999 će obavijestiti policiju. U takvom slučaju korisnik snosi punu moralnu, materijalnu i krivičnu odgovornost.
10. Korisnik se obavezuje da će tokom najma brinuti o tehničkoj ispravnosti vozila, tj. da će redovno provjeravati tečnost za hlađenje , ulje, pritisak u gumama, itd. Tako izazvani troškovi biće nadoknadeni korisniku po vraćanju vozila uz priloženi račun. Korisnik je odgovoran za sve vrste štete uzrokovane nepravilnim održavanjem vozila i neblagovremenim tehničkim pregledom vozila.
11. Korisnik je odgovoran za štete na vozilu koje izazove nepravilnim korišćenjem vozila ( korišćenje vozila van asfaltiranih puteve i sl.) bez obzira da li je platio osnovno ili puno kasko osiguranje. Korisnik će se teretiti za troškove vuče oštećenog vozila, troškove smanjenja vrijednosti vozila i gubitak prihoda po tom vozilu tokom popravke. Korisnik će takođe snositi troškove izazvane nepravilnim korišćenjem vozila koje Rent a car 999 ima prema trećim licima.
12. Korisnik je odgovoran za štete koje tokom najma prouzrokuje korisnik ili treće lice ako je korsnik kod iznajmljivanja dao lažne podatke o sebi, svojoj adresi ili vozačkim ispravama. U slučaju štete prema trećim licima korisnik će snositi sve troškove koje Rent a car 999 može imati po tom osnovu.
13. Korisnik se obavezuje da će u vrijeme kad ne koristi vozilo isto zaključavati i užimati ključeve. Po završetku najma korisnik je obvezan vratiti ključeve i dokumenta ili nadoknaditi gubitak.
14. Korisnik sam snosi troškove garažiranja, parkiranja i kazni za prekršaje u saobraćaju itd.
15. Korinsik ne snosi troškove mehaničkih kvarova na vozilu ukuliko je preuzeo sve da do njih ne dode.
16. Kasko osiguranje ne pokriva gume, felne i donji dio vozila.
17. Korisnik se obavezuje plaititi sve troškove po ovom Ugovoru o najmu u zakonskom roku.
18. Vozilo je osigurano po osnovi a) casco b)auto odgovornosti
19. U slučaju da je korisnik prihvatio plaćenje po ovom Ugovoru, potpuno se isključuje odgovornost korisnika za štete na iznajmljenom vozilu. Prihvatanje CDW-a ne oslobođa korisnika od odgovornosti za slučajeve navedene u tačkama 11. i 12.
20. Korisnik se obavezuje štititi interes Rent a car 999 u slučaju nezgode tako što će :
  - Zabilježiti imena i adrese učesnika i svjedoka
  - Obavijesiti predstavnike Rent a car 999 i podnijeti izvještaj o šteti
  - Ukloniti vozilo na sigurno mjesto
  - Pozvati i pričekati saobraćajnu policiju radi izvršenja službenog zapisnika. Ako korisnik propusti preduzeti navedene mjere u slučaju nezgode, biće odgovoran za sve tako izazvane štete i posljedice
21. U slučaju spora po ovom Ugovoru i računu nadležan je sud u Podgorici

## General rental conditions

1. I&J World Wide Investments d.o.o., hereinafter Rent a car 999 a car rents a car mentioned on the front side of this agreement, within the period of time and under the conditions set on front side of this document.
2. By signing this agreement the renter confirms that he had received the vehicle in good condition, with fuel level mentioned on front side, if different not specified on the rental agreement.
3. Renter shall pay all fuel consumed during the rental.
4. Renter undertakes to return of the vehicle together with all tires, tools, car documents, standard and additional equipment, as it was rented,
5. Renter will return the vehicle on the date specified here in or at such earlier date as Rent a car 999 may require. For each extension on the rental period, the agreement of Rent a car 999 a car has to be obtained 24 hours in advance and an additional sum for deposit paid simultaneously.
6. The vehicle may be operated only by the renter or by such person authorized in writing on this rental agreement, provided that such person meet all necessary qualifications and documents.
7. The vehicle shall not be operated
  - If the renter is under the influence of alcohol or drugs
  - To push a tow of other vehicle
  - While overloaded, i.e. carrying more passengers or freight than permitted by the car registration papers
  - To transport animals, combustible or explosive freight, freight with strong, unpleasant smell, or carrying any freight that can damage the vehicle
8. Renter shall not assign his rights hereunder or sell the vehicle or parts thereof.
9. If the renter prolongate his rental without prior agreement with Rent a car 999, it is considered that the car was illegally appropriated, and Rent a car 999 will inform the police authorities. In that case, the renter will be considered morally and financially responsible.
10. Rentar undertakes to take good care of var, particularly to check regular water, oil and tire pressure and to effect the necessary changes. Receipt shall be presented to Rent a car 999. Renter is made liable for all damages caused by insufficient maintenance.
11. Renter is liable for all damages caused to the vehicle as a result of the utilization on the road, this also if renter has accepted the CDW. In addition, the renter will be charged for the collection of the damaged vehicle, any reduced value of the vehicle and the loss of revenue due to immobilization during repairs. For all damages to third parties as a result of utilization off the roads renter is liable to any expenses incurred by Rent a car 999 which result from such damage.
12. Renter is liable for all damages to vehicle caused until return of the vehicle by renter of third parties, if he had supplied Rent a car 999 with false information as to his identity, his address or the validity of his drivers licence. In case of third-party damage renter shall be liable for any expenses incurred for replacement of same.
13. Renter hereby releases Rent a car 999 from liability for loss or damage to any property left, stored and transported in or upon the vehicle before or during the rental or after the return of the vehicle. Renter agrees to hold Rent a car 999 harmless from all claims and costs based upon such loss or damage.
14. During the rental period renter shall pay costs of parking, traffic or other legal violations assessed against the vehicle, as well as all other costs that are not regular.
15. Renter while using his best efforts to prevent such events, shall not be liable for any faults or defects in or from mechanical failure of the vehicle.
16. Insurance does not cover damages of the tires, wheels and the lower part of the vehicle. In case of seal damage or car failure, renter shall stop driving and inform Rent a car 999, where he will get instructions for further procedure.
17. Rent a car 999 is not liable for any consequences caused by any defect on the vehicle during the rental.
18. Rented vehicle is insured with a) comprehensive insurance and b) collision insurance
19. If the user has accepted the payment in compliance with the subject Agreement, the user's liability concerning damages on the rented vehicle is completely excluded. Acceptance of CDW does not release the user from the liability for the cases mentioned under the item 11 & 12.
20. Renter agrees to protect the interests:
  - Obtaining names and addresses involved and the witnesses
  - Not abandoning the vehicle without adequate provisions for safeguarding and securing the same
  - Calling the nearest Rent a car 999 station and giving a detailed report
  - Calling police in order to obtain the police report. If the renter fails to take the above stated actions, he will be held responsible for any consequence caused to Rent a car 999
21. All disputes arising in connection with the agreement shall be settled by the authorized court in Podgorica.
